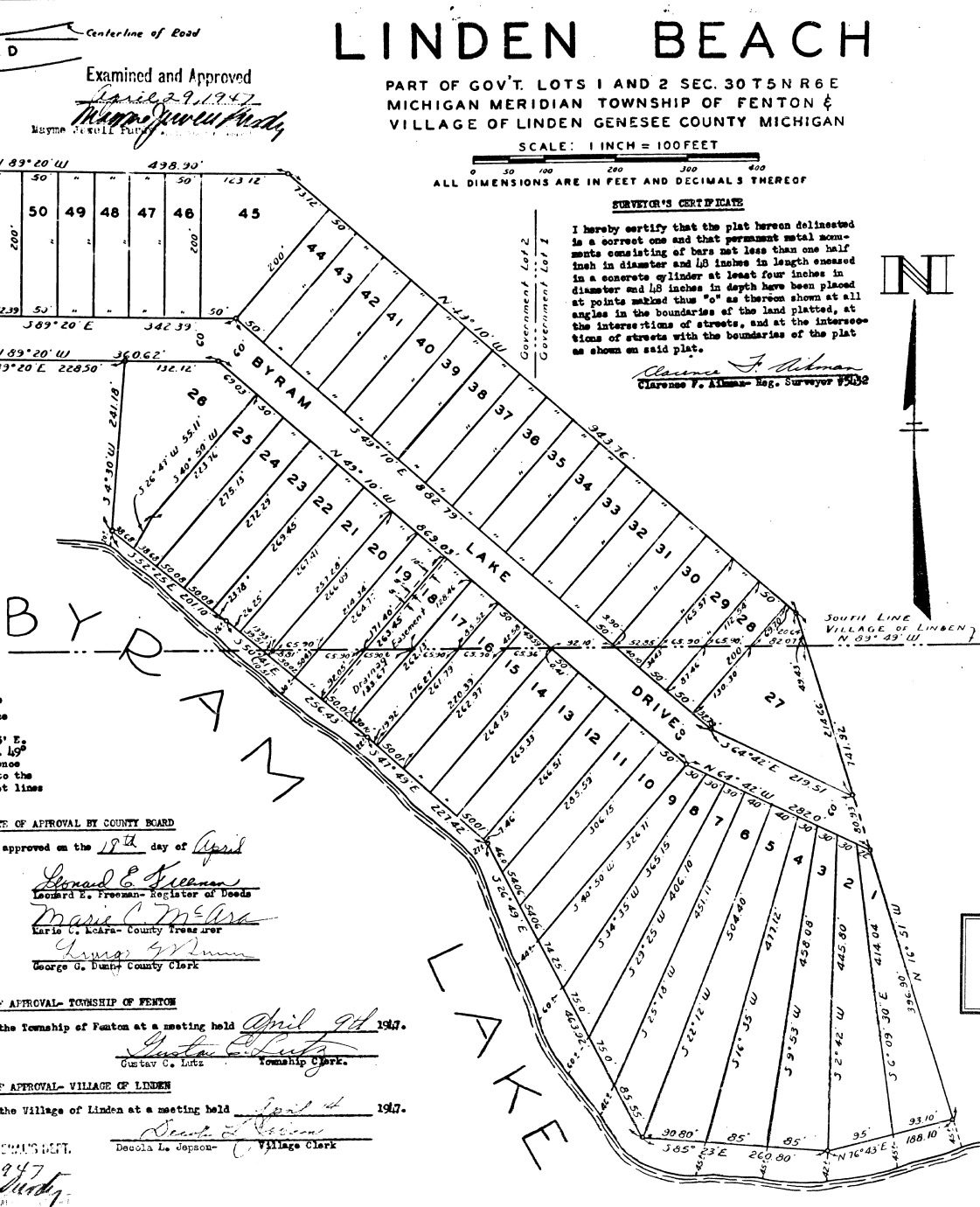
PART OF GOV'T. LOTS 1 AND 2 SEC. 30 T5N R6E

DESCRIPTION OF LAND PLATTED

The land embraced in the annexed plat of "LINDEN BEACH" Part of Gov't. Lots 1 and 2 Sec. 30 T5N R6E Michigan Meridian, Township of Fenton & Village of Linden, Genesee County, Michigan is described as follows: Beginning at a point in the centerline of Silver Lake Road S. 89° 17' E. 408.5 feet from the North Quarter Post of said Section 30, thence S. 0° 50' N. 650 feet, thence S. 21° 58' E. 302.71 feet, thence S. 89° 20' E. 228.50 feet, thence S. 4° 30' W. 241.10 feet, thence S. 52° 25' E. 201.10 feet, thence S. 50° 41' E. 256.43 feet, thence S. 17° 49' E. 221.42 feet, thence S. 28° 49' E. 169.92 feet, thence S. 89° 23' E. 260.80 feet, thence N. 76° 43' E. 188.10 feet, thence N. 16° 51' W. 711.92 feet, thence N. 49° 10' W. 943.76 feet, thence N. 89° 20' W. 496.90 feet, thence N. 21° 58' W. 37.75 feet, thence N. 0° 50' E. 638.02 feet to centerline of Silver Lake Road, thence N. 89° 17' W. 60 feet to the place of beginning. Lake front lots include land to the low water mark between the side lot lines extended to said low water mark.
