RE: 2020 Planning Commission Annual Report

The City of Linden Planning Commission is pleased to provide this Annual Report of its activities for calendar year 2020. This report is being submitted in compliance with Section 19 of the Planning Enabling Act, Public Act 33 of 2008, as amended. The Act states that: A planning commission shall make an annual written report to the legislative body concerning its operations and the status of planning activities, including recommendations regarding actions by the legislative body related to planning and development.

2020 was an unusual year, with the unexpected COVID-19 pandemic greatly influencing daily activities for all. Given the pandemic, adjustments had to be made – in particular, the conducing of business through virtual means – but the Planning Commission and City Administration were still able to accomplish many tasks. The following is a summary of the Commission's activities in 2020:

This Master Plan Update will be consistent with best practices for redevelopment ready communities (RRC) as established by the Michigan Economic Development Corporation (MEDC) in their State-wide RRC program. The Master Plan Update would include new sections on priority redevelopment sites, economic development and marketing. The Planning Commission envisions a collaborative planning process working with the City Council, DDA, ZBA, HDC, citizens and stakeholders.

In 2021, members of the Planning Commission will be notified of and may consider attending planning and zoning related training opportunities. Various training opportunities are available through organizations such as the Michigan Municipal League and the Michigan Association of Planning.
